

Field Rental Agreement

Clarksville Little League Park ❖ Clarksville Adult Softball Complex

RENTAL RATES	OVER 5 HOURS	UP TO 5 HOURS
FIRST FIELD	\$250	\$200
EACH ADDITIONAL FIELD	\$150	\$100

Rates listed are per field / per day.

Damage / reservation deposit of \$50 per field / per day must be paid in order to secure the reservation. Reservations will not be accepted without the deposit payment. Cancellations must be made 1 week prior to rental date. Failure to do so will result in loss of deposit.

If the complex is left like you found it and there is no damage or debris, the FULL security deposit will be returned. Please allow 30 days processing for the return of your deposit.

The rental fee is due 1 week prior to the rental. If payment is NOT received in full by the due date on this contract, reservation will be CANCELLED without notice.

Field(s) may be rented from 7am until 10pm. **Gates will not be unlocked earlier than 7am. In respect of our neighbors, the lights MUST be turned off by 10pm.** Fields not used for tournament play may be rented for \$50 per field / per day for warm-up. Field maintenance will not be performed.

A parks department employee will be on duty at all times during your rental. Renter must have a representative on site at all times to control rules (i.e. smoking, bikes, pets, soft tossing into fence, etc.)

As long as there is not a scheduling conflict, a parks department employee will hand-rake and chalk fields after every three (3) games if requested by renter.

Renter may not provide concessions at Little League Park unless the contracted concessionaire declines the opportunity. The concession stand at the Softball Complex may be rented for a fee of \$150 per day.

Renter must pick up all trash and debris within the complex: field playing area, dugouts, bleacher area, sidelines, restrooms and parking lot at the end of each day. A parks department employee will empty trash cans 1 time per day and will furnish trash bags for use throughout the day. Failure to keep complex clear of trash and debris will result in loss of deposit.

Renter must encourage teams to use hotels, restaurants and businesses located within the Town of Clarksville. Contact the Clark – Floyd Counties Convention and Tourism Bureau at 812-282-6654 or tourism@GoSolN.com.

PLEASE READ CAREFULLY: I understand that . . .

- Any person(s) renting the facility must be 21 years of age or older
- I am responsible for the supervision of my group; I am responsible for any damage incurred to the property, and I am responsible for the cleaning of the facility after use. I am also responsible for making sure the facility is restored to its state in which it was rented.
- I must carry insurance and provide proof of said insurance, naming the Town of Clarksville and the Clarksville Parks Department as co-insured concerning the following:
 - (a) Liability coverage for players, spectators, coaches, volunteers, and others in or near the facility.
 - (b) Liability and casualty for the premises of the baseball and softball fields, buildings and equipment.
- Any long-term agreement for the use of the facility may be terminated should the circumstances dictate that the facility is needed for department programs. In such situations, at least five (5) days notice will be given to the renter of the facility.
- "It shall be unlawful to possess, consume, or bring alcoholic beverages onto the Clarksville Little League Park and Clarksville Softball Complex." (Ord. 97-G-02)

The undersigned certifies that they have the authority to sign on behalf of the group or organization or other persons who will be using the facility for which this permit is granted. The undersigned further assumes full responsibility for the supervision of his/her group and the safety of other participants who will be in Clarksville and will hold harmless the Clarksville Parks and Recreation Department and any agent of said Town or Park District of any liability or responsibility, and further agrees to indemnify them and hold them harmless from any losses, including court costs and/or attorney fees. That this waiver and release is granted in exchange for the permit of use of the Civil Town of Clarksville or the Clarksville Parks and Recreation Department, its owners, agents, servants, and/or employees for any damages, injuries, or any other cause of action.
